- New Business
 - Policy 4210 changes
 - Changes to the American Government requirement
 - HS students starting with this year's Junior year are required to take a civics test, which is similar to US citizens test
 - Change:
 - "Must pass (70% or better) the MO Constitution, Federal Constitution, and US Citizenship Tests."
 - KG: Questioning the naming. Should it not be the same name as defined on the government document: "Civics Test"
 - AC: If questions can be incorporated, the name should not matter
 - NS: Feels the name of Citizens Test should carry more weight.
 - AF: Verbiage should also be added to the 4210.2 Honors Diploma verbiage
 - KB: Will be monitoring the DESE website in the future to catch these sorts of changes sooner.
 - \circ $\;$ NS: Asking if colleges acknowledge the honors diploma.
 - KG: Feels we started around 2011
 - KB: Colleges look more at GPA and credits than diploma type.

 - KB: It is not

- o Donation Request Letter
 - After kickoff, people asked about the donation section in the budget.
 - Feels we can get this number higher by reaching out to businesses.
 - AC, Gay Otten, and Richard DeFord have worked on multiple letters.
 - AC: Discussed the section at the bottom about what amounts of money could be used for.
 - NS: Likes the concept, would like to see 300, 600, 1200 option
 Doesn't necessarily like the option for 1 student.
 - JG: Making sure there is no overlap between this letter and what the Boatright's would be sending:
 - AF: The Boatright's may want to give this up.
 - JG: But they may carry more weight than what we could do on our own.
 - NS: We may be able to combine these 2 process and have the sender use a customized cover letter.
 - JG: The amount categories is helpful to let people know what is typical
 - JG: The minimum amount that we send a tax form should also be noted.
 - MS: Likes the levels for corporate and churches, but would like an open ended amount for individuals.
 - Possibly remove levels from the individual letters.
 - KG: Feels mentioning that funds could be used for tuition is contradictory to the letter verbiage.
 - KG: Is it off to ask that some of these funds might end up back in the community?
 - We have a community coordinator.
 - DW: Would make sure we include students to this context so they know the students are benefiting from the process.
 - DW: Should leave an option for general funds to support a high quality education.
 - AF: Would it be hard to keep track of if someone earmarks funds for?
 - DW: Need to add a note on the letter allowing the school to use the funds as needed.
 - ACTION ITEM: AC to update document and distribute to the board.
 - NS: Would like to see the list that documents are being sent in the future.
