5300.1 Mission Statement: To develop and train Christ-like leaders to serve Applewood Christian School, their church, and the community.

5300.2 Leadership Positions: (Term length will be one school year)

5300.2.1 President

- 5300.2.1.1 Must be a junior or senior
- 5300.2.1.2 Must maintain an overall GPA of 3.5
- 5300.2.1.3 Must be in good standing according to the ACS attendance/tardy policy.
- 5300.2.1.4 Must display overall Christ-like character in the classroom according to teacher recommendations.
- 5300.2.1.5 Will preside over student council meetings.
- 5300.2.1.6 Will represent the student body at Maplewood congregational meetings and ACS board meetings.
- 5300.2.1.7 Will be liaison between ACS administration and student body.
- 5300.2.1.8 Will have held a prior leadership position in the Student Council.

5300.2.2 Vice-President

- 5300.2.2.3 Must be in good standing according to the ACS attendance/tardy policy.

- 5300.2.2.6 Will chair committees

- 5300.2.6.7 Will submit news worthy information to Sedalia newspapers (Democrat, Sedalia News Journal).
